- **116 original practice questions**, organized into 14 topics, in the multiple-choice format used by the MPRE, so that students can test their understanding of each topic studied in the course.
- **Detailed narrative analyses of the answer to each question**, explaining why one choice is correct, and why each incorrect answer is not correct
